There being a quorum present the meeting came to order at 4:30 pm.

Those in attendance introduced themselves as requested by Chairman Wingo.

3. New Board Member. Chairman Wingo introduced Stephanie Davenport as the new airport board member. Mrs. Davenport stated she grew up in Montgomery County and for the past 8 years worked within Montgomery County government.
  
1. Consider approval of the January 14, 2019 regular meeting minutes. Mrs. Laukien made the motion to approve the minutes. Mr. Yount seconded the motion and the motion carried.
  
2. Citizen/Tenant Comments. Vickie Croston stated she is involved with Challenge Air and requested that the ramp area where Challenge Air will be held be cleared of all aircraft other than those participating in the Challenge Air event. Mr. Brown stated he was unaware there was an issue last year but can most certainly contact those who operate this ramp area to make sure this ramp is cleared for the event which will be held November 9, 2019.
  
4. Airport Update. Mr. Brown presented the board with the March airport updates. Those updates are attached and made a part of these minutes.
  
5. Other Matters. Mr. Brown advised that the Tora group will be holding their annual practice this upcoming weekend. The NOTAM is 9 am – 5pm Saturday and Sunday. Tower will work aircraft in and out of the airport around the Tora aircraft.

Mr. Crebbs stated he has noticed a shortage of hangar space at the airport and asked what is being done to increase space on the airport. Mr. Brown stated the airport has historically done a great job in allowing private development of hangars on the airport. Mr. Brown stated there are many hangars on the ground and there are currently two hangar projects underway and another in the preliminary planning stage. Galaxy FBO has area available for hangar development as well. Mr. Brown stated he would like to look at public/private partnership developments in the future.

There being no further business Mr. Yount made the motion to adjourn. Mrs. Laukien seconded the motion and the motion carried. The meeting adjourned at 5:10 pm.
