- 1. Consider approval of the April 13, 2015 and the April 28, 2015 regular meeting minutes. The approval of the minutes was deferred due to lack of a quorum.
- 2. Citizen/Tenant Comments. Jere Gardner advised that effective July 1st the tower staff will be reduced to one controller after 5pm. Mr. Gardner stated that he has concerns with the amount of Galaxy golf cart runway crossings. Mr. Ratcliff agreed and stated he feels that there are too many golf cart crossings.

Mr. Smith stated that Galaxy has an operational need to cross the runway. Mr. Gardner disagreed stating that Galaxy has an alternate route via Loop 336. Mr. Gardner stated that there is a FAA letter that addresses limiting runway crossings.

Mr. Smith suggested notifying Galaxy that effect July 1st they will no longer be allowed to cross the runway after 5pm. Mr. Gardner stated this will help but it is only a band aid. Mr. Gardner stated he has nothing again Galaxy or its employees but the golf cart crossings are a safety issue.

Mr. Wingo and Mr. Yount agreed that the crossings are certainly a safety issue and need to stop. Mr. Wingo requested that Mr. Smith meet with Galaxy to discuss a better alternative and notify them that the crossings will no longer be allowed. Mr. Smith stated he would meet with Galaxy regarding the issue and asked if Mr. Wingo would like to join him. Mr. Wingo stated he would.

Mr. Gardner stated that with the new tower hours of 6am – 9pm, he has not noticed any more traffic. Mr. Smith stated he has traffic numbers that support the time change and would like to give the new schedule one year before reviewing the traffic numbers again.

Mr. Wingo asked if the county can tell RVA, the tower contractor, that their new staff schedule which allows for only one controller after 5pm is unacceptable. Mr. Smith stated that the county has the right to make the request but RVA is not obligated to make any changes. Mr. Smith stated there are multiple towers with only one controller during certain times of the day.

Mr. Yount asked about how the county should proceed with notifying RVA about their concern with the reduced tower staff. Mr. Smith stated he will have the opportunity to discuss the matter with the FAA while his is in Washington in a few weeks. Mr. Smith stated he will follow up on the matter.

- 3. Updates. Mr. Smith presented the board with the June updates. Those updates are attached and made a part of these minutes.
 - Mr. Smith advised that TxDOT did approve the CIP with requested changes.

Mr. Yount asked about the construction of the League Line road extension. Mr. Smith stated that construction is on schedule since this project was not funded with potential bond money.

- 4. Taxiway Location and Directional Signs. Mr. Smith presented the board members with his plan for additional signage. Mr. Smith explained that there is a need for additional signage that was not included in the runway project. Mr. Smith stated that his plan includes unlit signs but reflective signs that will be installed by his staff members. Mr. Wingo stated he liked the plan for additional signage.
- 5. Other Matters. Mr. Ratcliff asked the status of Texas Air Shuttle. Mr. Yount stated they are waiting on the FAA for their certification.


There being no further business the meeting adjourned at 5:25 pm.



- Complete, ribbon cutting was March 23, 2015

- 8 asphalt concrete transitions to be re-surfaced
